5. TREASURER'S REPORT – ALEXA VINES

- · Account Balances
 - o Checkings account: \$64,416.91
 - o Savings account: \$47,355.76
 - o Total: 111,772.67
- a. Paid IRS the balance of \$3,000
 - · IRS confirmation form was not sent in 2015
 - 1. NSANYS owed a balance of \$3000
 - 2. Charged everyday it's late
- *Chase bank reimbursed \$3,600 to our account due to the fraud
- *Alexa will present a budget within the next 2 weeks, will have a finance committee meeting to discuss

Council of School Leaders

Discussion -

- NSANYS to partner with ANA and host the Council of State Leaders this September
- i. NSANYS will pay for state president's registration fee (\$50), and transportation
- ii. Plan for 60 people to attend need a final estimated cost when closer to date
- iii. If 50 presidents attend \rightarrow cost is estimated to be \$2500 + board and travel } \$5,000-\$6,000 commitment
- Helen is organizing an Equinox fundraiser event that raises awareness of situations for adolescents, domestic violence, children, elderly, those with mental illness –The venue to drop off the clothes is only 5 minutes away from where COSL will be but not open on the weekends manager said she could try to make an exception
